Annsley described that the board removed all SUUSIship language from their manual.

All of this policy language has been moved over to The SUUSI Foundation policy manual in section 6.

Annsley removed the language about submitting references and tax returns because we were not asking for references and we want to allow people to apply for SUUSIships for reasons other than financial hardship.

Deleted wording about what percentage of SUUSIships would go to which type of recipient.

Changed the language about volunteer hours for ages 10-13 years old to be replaced with service project instead of volunteer hours.

Annsley answered some logistical questions about how SUUSIships work and how the The Foundation board functions to new members.

Eliminated the finance investment committee and removed it from the policy now that we have hired a professional advisor.

Ed motioned to accept policy \Rightarrow Angel seconds \Rightarrow unanimous vote to accept policy

Financial Updates

- How is SUUSI looking for 2022?
 - So far it does not look like SUUSI will need any money from the foundation to put SUUSI 2022 on, but they may need a grant to cover expenses after SUUSI.
- Foundation Balances & Investments
 - Foundation investment- not accessible by the president at this time
 - o Operating budget \$43,296
 - o endowment \$105,265
- Money Spent Since Last Meeting
 - o No money spent since last meeting
